The Department of Studies in Law was established in 1973. The Department was first headed by Prof. Sreekantaiah. Subsequently, Prof. C. K. N. Raja joined the department as Professor of Law and became the Chairperson. In South India, this Law department is at the forefront in providing higher education in law. It offers two years (4 Semesters) of LL.M Programme with optional branches such as Constitutional Law, International Law and Business and Trade Law. It promotes research and a Ph.D. in Law is also available. The LL.M study at the University of Mysore is known for the high component of training in Law research. The candidate has to fulfill the degree with dissertation work. Some of the student dissertations are published and have earned much appreciation.

The DOS in Law is known for intensive and high-quality teaching. Therefore, students from various parts of India, as well as foreign countries such as Kenya, Tanzania, Iraq, Iran, Afghanistan and Tibet seek admission here. The building is equipped with a good library, computers and other technological facilities. Every year, approximately 10 to 12 foreign students join the Department.
