**REVISED REGULATIONS GOVERNING THE CONDUCT OF ENTRANCE
EXAMINATION AND ADMISSION TO MYSORE UNIVERSITY
POST-GRADUATE DEGREE/DIPLOMA COURSES, 2000**

(As approved by the Govt. of Karnataka, vide letter No. ED/25/UMS/2000, Dated 4.9.2000)

1. TITLE AND COMMENCEMENT

These Regulations shall be called "Revised Regulations Governing the conduct of Entrance Examination and Admission to Mysore University Post-Graduate Degree/Diploma Courses, 2000" and they shall come into force from the date of assent by the Chancellor.

2. SELECTION COMMITTEE

- a) There shall be a Selection Committee for each course of study to conduct the Entrance Examination and for admission to Post-Graduate Degree/Diploma Courses.
- b) The Selection Committee shall consist of three members. The Chairperson of the Department concerned/Director of the Institute/Course Co-ordinator shall be the Chairman of the Selection Committee. Two members in the subject concerned/Department/Institute/Course shall be the members of the Committee by rotation on seniority basis.
- c) The Selection Committee shall be constituted every year by the Vice-Chancellor.

3. FUNCTIONS OF THE SELECTION COMMITTEE

- a) It shall be the responsibility of the Selection Committee to conduct Entrance Examination.
- b) The Selection Committee shall select the candidates as per Regulations.
- c) It shall be the responsibility of the Selection Committee to finalize the admission of the candidates as per the directions of the University.

4. CONDUCT OF ENTRANCE EXAMINATION

- a) The Entrance Examination shall be of two hours duration and the maximum marks shall be **one hundred**.
- b) The Foreign Nationals who have a Foreign Degree shall be exempted from taking the Entrance Examination
- c) The syllabus for the Entrance Examination shall generally be the syllabus of cognate subject at the Bachelor's Degree level.
However, in respect of those Courses where the cognate subjects are not specified, the syllabus for the Entrance Examination is the one prescribed by the department concerned and supplied along with the prospectus.
- d) If the number of applications received for a course is less than or equal to the intake, the entrance examination need not be conducted for such course.

5. SETTING OF QUESTION PAPERS

It shall be the duty of the Selection Committee to prepare two sets of Question Paper and send the same to the Registrar (Evaluation). The Registrar (Evaluation) shall choose
